Consequent upon the revision of Pay and Pay Scales by the Principal Secretary to the Government of Rajasthan, Law & Legal Affairs Department, Jaipur vide Order/Notification No. No.F.26(12)Nyay/2009 dated 03.05.2010, present Pay and Pay Scales of Rajasthan Judicial Service Officers (Entry Level) i.e. Rs.9000-250-10750-300-13150-350-14550 has now been revised as Rs.27700-770-33090-920-40450-1080-44770.


