
I am directed to issue a corrigendum after Pre-bid meeting for the advertisement of NIT for FOR SUPPLY AND INSTALLATION OF OFFICE FURNITURE AND STORAGE (COMPACTOR) FURNITURE AT NEW BUILDING OF RAJASTHAN HIGH COURT, JODHPUR. Please find below the corrigendum as under:-

1. To add in the abbreviation and definition part at page number 3 of the RFP, definition as "Furniture/Office Furniture:-
"The term 'Furniture/Office Furniture' used wherever in the RFP would mean Office Furniture and Storage (Compactor) Furniture."
2. In eligibility criteria at page number 11 of RFP
 - (i) "Point i(a) line 1 'Office furniture' be replaced by 'Office furniture and Storage (Compactor) furniture'."
 - (ii) "Point i(d) line 1 'Office furniture' be replaced by 'Office furniture and Storage (Compactor) furniture'."
 - (iii) At Point i(d) line 3 before word 'etc', word 'compactors' be added.
3. At page number 39, BILL OF MATERIAL (BoM) Anex. "A" & "B", be replaced by BILL OF MATERIAL (BoM) consisting part "A" & "B"
4. At page number 11 in eligibility criteria point (f) be added as under:
"A bidder should quote rates for all items i.e. for all items mentioned in part "A" & "B" of Annexure-1 (BoM) read with item numbers 1.01 to 1.63, 2.01 to 2.19 and 3.01 to 3.07 mentioned in Annexure-7 (BoQ), meeting out the specifications mentioned in part "A" and "B" of Annexure-2"

5. At page number 11 in eligibility criteria point number 1(ii)(2) contents of Net Worth in column of specific requirements be amended as under :
“The net worth of bidder in the last financial year i.e. 2016-17, should be positive.
The bidder’s, ‘annual turnover’ from sales and support services of similar work in India, in last 5 years, should be minimum 50 Crores in total.”
6. At page number 28 point number 32(b) line number 6 the word “INR 30 Crores” be replaced with “an amount equal to 50% of the bid value”.
7. At page number 10 in point number 6 a new para as (k), at page number 18 in point number 8 a new para as (b1) below para (b), at page number 52 new bullet in Note and at such other places where a similar reference may be comprehended in the bid document, the following may be added:
“Specifications mentioned in the bid document are only illustrative and indicative. Any reasonable variation depending upon the items supplied by the successful bidder duly approved by the Committee of Rajasthan High Court as per its actual site specific layout / fabrication drawings may be considered.”
8. At page number 14 point number 8(b)(4) and page number 83 point 12 with regard to document requirement of EMD be replaced with “Scanned copy of DD/ Banker’s Cheque/ Bank Guarantee as per RTPPP Act, 2012”.

The tenderers who have already submitted their tender are requested to change their offer within the prescribed period, if they so desire. Corrigendum will be also available on Rajasthan High Court website www.hcraj.nic.in. The rest of contents of RFP will remain same.
