

**RAJASTHAN HIGH COURT, JODHPUR**  
**ORDER**

WHEREAS, an order placing under suspension Shri Vinod Kumar Gupta, the then Civil Judge (Jr.Dn.) & Judicial Magistrate, Ghatol ( District-Banswara) was made vide this office order No. Estt. (RJS) 86/2013 dated 14.7.2013 and a departmental enquiry under rule 16 of the Rajasthan Civil Services (Classification, Control and Appeal) Rules, 1958 has been initiated against him;

AND WHEREAS, during the period of suspension Shri Vinod Kumar Gupta was allowed subsistence allowance at an amount equal to the leave salary which he would have drawn, if he had been on leave on half pay and in addition dearness allowance based on such leave salary;

AND WHEREAS, a period of six months has elapsed and the suspension has not been prolonged due to the reason directly attributable to Shri Vinod Kumar Gupta;

THEREFORE, under Rule 53 (1) (i) of the Rajasthan Service Rules, the subsistence allowance admissible to Shri Vinod Kumar Gupta is increased with effect from 14.01.2014 to 50 percent of the subsistence allowance admissible to him during period of first six months.
