The order of appointment of **Shri Brahmanand Sharma** to the Rajasthan Judicial Service as Civil Judge (Junior Division) & Judicial Magistrates in Civil Judge Cadre has been issued by the Principal Secretary to the Government of Rajasthan, Law & Legal Affairs Department, Jaipur vide No.F.19(7)Nyay/2011 dated 13.03.2014. The appointment of Shri Brahmanand Sharma would be with effect from the date he assumes charge as a trainee. He is directed to report at **HCM, RIPA, JLN Marg, Jaipur on 26.11.2014 at 09:00 a.m. Sharp.**

The Seniority of Shri Sharma shall remain the same as declared by the Rajasthan Public Service Commission, Ajmer.

He shall be paid basic salary in the Pay Scale of Rs.27,700-770-33,090-920-40,450-1080-44,770 and allowances admissible thereon.

He is required to submit a declaration under Rule 25-A(2) of the Rajasthan Civil Services (Conduct) Rules, 1971 to the Controlling Authority at the time of joining or within one month of his marriage, as the case may be, signed by his father/wife and father-in-law to the effect that he has not taken dowry directly or indirectly and in any manner.
