- 9. He has to join his duties on or before 20.02.2017 in the office of Registrar (Administration), Rajasthan High Court, Jodhpur, failing which, his Appointment order shall stand cancelled automatically without any further notice.
- 10. Your Pay will be fixed in the running pay band PB-1, 5200-20200 & grade pay 2400 after successful completion of probation-training period and you will be entitled to get other allowances as per rules.
