On recommendation of Hon'ble Rajasthan High Court, Jodhpur Shri Ajay Kumar Ojha, District & Sessions Judge, Sawaimadhopur is appointed as Judge, Family Court, Sawaimadhopur in addition to his own duties w.e.f. 01.11.2015 till further orders, on following conditions.

Note:-
