NOTICE

Result of the Competitive Examination, 2013 for the recruitment to the post of Junior Personal Assistant (short hand speed assessment test) held on 22nd and 23rd June, 2013 at Jodhpur, pursuant to notification NO.ESTT./HC/2013/20 dated 09.01.2013 is hereby declared.

None of the candidates is found to have qualified the speed test for want of requisite short hand speed of 100 words per minute even after allowing 5% permissible mistakes as per rules and therefore; no candidate is selected for appointment to the post of Junior Personal Assistant (English).
