- (i) The determination of vacancies is inclusive of 10% posts being part of the cadre strength which are provided in Schedule-I for leave reserve/training/deputation in the Cadre of District Judge, Senior Civil Judge and Civil Judge.
- (ii) The 43 Posts determined against the Fast Track Courts are purely temporary in nature. In case the Fast Track Courts are abolished the officers appointed against these posts may preferably be adjusted against the vacancies which may arise due to retirements otherwise they will be discharged from service. In that case they will not claim any right on this account.

eCourts-Mission Mode Project-Rajasthan

The 'Cabinet Committee of Economic Affairs' (CCEA) has approved the Scheme of Computerisation of District & Subordinate Courts in the country and for up-gradation of Information & Communication Technology (ICT) infrastructure of the higher courts at a cost of Rs.441.8 Crores in February 2007. It was called eCourts Mission Mode Project. The Phase-I was planned to be implemented in a period of two years (Feb 2007-2009) in 2100 Court Complexes across the country consisting of 13000 District & Subordinate Courts.

In the second phase, ICT enabled at 969 Court Complexes covering 2249 Courts.

It would be creating information gateways between courts & public agencies and departments. The project is expected to lead to complete demystification of the adjudicatory process thereby ensuring transparency, accountability & cost-effectiveness.

The project has been devised following the report submitted by the E-Committee on National Policy & Technology in the Indian Judiciary. The project will be implemented by 31st March 2014 throughout the country.

- 8. Judicial Service Centre (JSC) has also been started at Jaipur District Court, Rajsamand District Court, Udaipur District Court, Sri Ganganagar District Court, Pali District Court and Bundi District Court. Case Information Status is provided to the advocates, litigants etc. at the Judicial Service Centres.

Some Recent Judgments of Rajasthan High Court

- 1. On 05.01.2012, Hon'ble Single Bench while deciding S.B.Civil Writ Petition No.1354/2002 Prakash Kachhawa Versus State of Rajasthan & Ors., held that service of an employee cannot be terminated under Rule-86 by verbal order on the ground of wilful absent without holding an enquiry.
- 2. On 05.01.2012, Hon'ble Division Bench while deciding **D.B.Civil Special Appeal(Writ)No.1876/2011**Rajendra Nagar Adarsh Gram Nirman Sahakari Samiti Versus State & Ors., held that when acquisition for public purpose is overlapping, acquisition could have been made by the Union for its purpose that does not necessarily cease to be a State purpose or a general public purpose for which State is competent being beneficiary. The acquisition was for betterment of State and to benefit the resident of the State of Rajasthan. The interest of Housing Societies cannot prevail over such interest.
- 3. On 09.01.2012, Hon'ble Single Bench while deciding S.B. Criminal Revision Petition No. 458/98 Ajay Kumar Parmar versus State of Rajathan held that Magistrate has no jurisdiction or power to refrain from committing the case to the court of Sessions when the charge sheet is filed. Magistrate while refusing to take cognizance on the police report for a Sessions triable offence, over stepped the jurisdiction and the learned Sessions Judge has rightly set aside the said order of the learned Magistrate.
- 4. On 10.01.2012, Hon'ble Single Bench while deciding S.B.Civil Contempt Petition No.766/2010 in S.B.Civil First Appeal No.220/2001, Dev Kishan Versus Madan Lal @ Madan Mohan held, that stay order should not be interpreted narrowly as the intention of passing such stay order clearly shows that no such steps would be taken by either of the parties which may adversely affect the rights of the party in possession at the time of passing of the order. Misunderstanding or own understanding cannot be a permissible defence.
- 5. On 13.01.2012, Hon'ble Single Bench while deciding S.B.Civil Writ Petition No.7679/2002, Ashok Kumar V/s State of Rajasthan & ors. held that Review Committee has no power to abolish the post. For termination of even temporary employee, in the event of abolition of posts, it is expected from the respondents to give notice and apprise the employees, as to why their services are liable to be terminated on abolition of post. No such notice has been issued in the present case which is contrary to the true spirit of Section 12(a) of the Rajasthan(Regularization of appointment to Public Services and Rationalization of Staff)Act, 1999.
- 6. On 1.2.2012, the Hon'ble Single Bench while deciding S.B.Civil Misc. Appeal No. 596/97, Panney Singh vs. Sharad Kumar & Ors., while interpreting the provisions of Motor Vehicle Act, 1939, held that the liability of the Insurance Company under Section 95 of the Act is unlimited where premium of Rs. 240/- was charged for 'Public Risk' instead of Rs. 200/- for 'Act only liability'.

- 7. On 2.2.2012, Hon'ble Single Bench while deciding S.B. Civil Writ Petition No.10448/2010, Akashdeep Arora & Anr. Vs. State of Rajasthan & Anr., held that by applying the roaster point and taking note of the posts advertised in the year 2003 and 2007, the determination of reservation in favour of the disabled persons may be made as per roaster point. Therein, the provisions of Section 36 of the Act of 1995 may be taken note of where interchangeability of one category to another is made permissible.
- 8. On 13.02.2012, Hon'ble Division Bench while deciding **D.B.Civil Writ Petition No.15031/2011 S.N.Sethi Versus Union of India & ors.**, held that if a criminal charge is pending or sanction for prosecution has been issued or decision has been taken to accord sanction for prosecution or in investigation on **serious allegation of corruption**, **bribery or similar grave misconduct is in progress either by C.B.I. or any other agency, then procedure of keeping the recommendation of D.P.C. in a sealed cover shall be applicable in case of government servant**. The petitioner would be eligible for regular promotion only after exoneration from the charges leveled against him.
- 9. On 29.02.2012, Hon'ble Single Bench while deciding S.B.Criminal Appeal No.1852/2007, Mohan Lal Versus The State of Rajasthan, held that requirement of Section 50 of the N.D.P.S. Act has been fully compiled with as the option was given to the appellant. Further, the difference in weight of contraband substance is minor due to use of basic weighing machine and much more improved and sensitive machine at laboratory. Acquittal of co-accused cannot be a ground for acquittal of appellant when the recovery of opium is established from him.
- 10. On 16/3/2012, Hon'ble Single Bench in S.B.Civil Revision Petition No. 188/2011, Ganga Singh Vs. L.Rs of Chhotu Singh & ors., while interpreting the provisions of Partition Act, 1893 held that the preemptive right of the co-sharer under Sections 3 and 4 of the Act comes to an end with actual sale of property in an auction in favour of third party and such auction cannot be made a tool to determine the market value of the property and the only course open to set aside the auction is the procedure laid down under Order 29 Rule 89 CPC. The Court further opined that since the petitioner in the instant case did not really & effectively exercise his right under Section 3 or 4 of the Act at any point of time nor he has deposited valuation of 3/10 share of property, so as to satisfy the decree in favour of auction purchaser, therefore, the purpose of filing application under Section 3 & 4 of the Act belatedly on 28.4.2011, cannot be said to be bonafide. The Hon'ble Court concluded that the right of preemption under section 3 & 4 of the Partition Act, 1893 cannot be said to be an absolute and over-riding right which cannot be defeated by estoppel or equity.
- 11. On 22.03.2012, Hon'ble Division Bench while deciding **D.B.Civil Writ (Parole) Petition No. 12294/2011**, **Shambhu Dayal Versus The State of Rajasthan & Ors.**, held that the Rajasthan Prisoners Release on Parole Rules, 1958 are not applicable in the cases where imprisonment for an offence against any law relating to a matter to which the executive power of Union extends and such cases have to be dealt with in accordance of Rules, 1955 framed by Central Government.

It was further held that as per Rules, 55 requirement of deposition of fine cannot be a condition precedent for consideration of application for parole.

- 12. On 3.04.2012, Hon'ble Single Bench while deciding SB Civil Writ Petition No.13882/2011, Rohit Sharma Vs. State of Rajasthan & Ors, while interpreting provisions of Rajasthan Civil Services (Pension) Rules, 1996 and Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, held that son or daughter of a Government servant suffering from specific disabilities prescribed in proviso to Rule 67 of the Pension Rules 1996 has been made entitled for family pension. However, there is a general mention of disabled son or daughter in the proviso to Rule 67 of the Rules of 1996 to earn a living. The disability has not been defined in any other rule relating to grant of family pension. Since there is a general mention of disability to earn a living in proviso to Rule 67 of the Rules of 1996, it would be appropriate to take the definition of disability mentioned in the Act of 1995 wherein the blindness has been included in the definition of disability. Thus, Hon'ble Court applying these provisions allowed the writ petition and held that the petitioner, who was totally blind since birth, is entitled to get family pension.
- 13. On 18.04.2012, Hon'ble Single Bench while deciding SB Criminal Misc. Petition No.892/2012, Prakash Chandra Vs. State & Raj. & Anr, held that it is the mandate of the Code of Criminal Procedure that every investigation should be completed without unnecessarily delay. Similar is the sprit of the Constitution of India that it is the right of every citizen to have a case, particularly a criminal case, to be investigated, enquired and tried at the earliest. Similarly, it is the right of the accused to have a criminal case decided expeditiously. Hon'ble Court has also held that delay in investigation does have a material effect and deep consequence on the result of the same. In the instant case, FIR was lodged in the year 2009 but the investigation was not completed till the date of passing of the order in this petition. Hence, Hon'ble Court gave various directions to the Director General of Police, Rajasthan for speedy investigation and conclusion of the same.
- 14. On 09.05.2012, Hon'ble Single Bench in SB Civil Writ Petition No.9440/2007, Managing Committee, Gaur Vipra Primary School Jaipur Vs. Civil Judge (Jr.Div.) & Ors, while interpreting the provisions of Rajasthan Non Government Educational Institutions Act, 1989 and the Rajasthan Non Government Educational Institutions Rules, 1989 and the Revised Pay Scale Rules, 1996 and the Revised Pay Scale (5th Pay Commission) Rules, 1998, held that pay scales to the teachers of Government Educational Institutions, by virtue of the statutory provisions, are also payable to the teachers of the Non Government Educational Institutions. It is the mandate of Section 29 of the Act that the scale of pay and allowances except compensatory allowances with respect to all the employees of an aided institution shall not be less than

those prescribed for the staff belonging to similar categories in Government Institutions. Scale of pay and allowances of employees of an aided institution shall have parity with the employees of Government. The scale of pay of the teachers in Non Government Educational Institutions, shall, therefore, be similar to that of the servants/ teachers in Government Institutions. Under Rule 35 also, the scale of pay and allowances of the staff of the aided institutions shall not be less than those prescribed by the Government for staff of similar category of the Government Educational Institutions. Thus, the Hon'ble Court dismissed the writ petition filed by Management Committee, being devoid of any substance.

15. On 10/5/2012, the Hon'ble Court in Anil Khatwani vs. Nistha Khatwani, CMA No. 1250/2008, while interpreting the provisions of Section 13-B of the Hindu Marriage Act, held that the unilateral withdrawal of consent of petition by the wife at the stage of second motion under Section 13-B(2) was merely to extort more money from the husband, as the amount of permanent alimony of Rs. 5.50 lacs was accepted by her under a compromise. The Hon'ble Court further observed withdrawal of such consent has to be examined in the background of the reasons given for such withdrawal of consent and it cannot be made a tool to frustrate the first petition under Section 13B of the Act or to extort more amount of permanent alimony. Finding the consent for obtaining divorce decree by mutual consent free and without any force, fraud or undue influence, the Hon'ble Court granted the divorce decree by mutual consent under Section 13-B of the Act.






