

Important Decisions Taken by Rajasthan High Court (Resolutions of Full Court & Committees) (From 01/01/2013 to 31/03/2013)

- * 15 meetings of Hon'ble Administrative Committee were held on various dates. 28 representations of Judicial Officers regarding upgradation/expunction of remarks in ACRs were finally disposed off.
- * Two Full Court meetings were held during first quarter of the year. Selection Scale of DJ Cadre granted to one officer. Shri Jag Mohan Agarwal-I, CJM was promoted as ADJ.
- * Transfer Policy framed by the Administrative Committee and was finally approved by Hon'ble Full Court.
- * Vacancies in DJ Cadre, Senior Civil Judge Cadre and Civil Judge entry level determined and were notified on the dates prescribed vide Schedule-III of RJS Rules, 2010.
- * Various modifications have been recommended in the Scheme of Law Clerk-cum Legal Research Assistant.
- * To simplify the procedure of reimbursement of medical expenses to retired Hon'ble Judge, The Draft Scheme for Reimbursement of Medical Expenses to the Retired Hon'ble Chief Justices/Judges of Rajasthan High Court as formulated by the Committee was approved by Hon'ble the Full Court and was forwarded to the State Govt. for its promulgation.
- * 15 Departmental Enquiries against Judicial Officers have been decided finally.
- * Two meetings of Higher Judiciary Committee and one meeting of Lower Judiciary Committee-II also held besides meetings of Purchase Committee, Building Committee, Budget Committee, Committee for working out the units of credit for work done by Judicial Officers and Committee for considering promotion of the Staff of High Court.

Nomination of Executive Chairman Notification

In exercise of the powers conferred by Clause (b) of Sub-Section (2) of Section 6 of the Legal Services Authority Act, 1987 (Central Act No.39 of 1987), Her Excellency the Governor is pleased to nominate **Hon'ble Mr. Justice Narendra Kumar Jain**, Senior most and Administrative Judge, Rajasthan High Court as **Executive Chairman of the State Legal Services Authority** vide Notification no. Some Recent Judgments of Rajasthan High Court

- 1. On 10.01.2013, Hon'ble Division Bench in DB Income Tax Appeal No. 1/2008, Commissioner of Income Tax Vs. M/s. Godha Chemicals Pvt. Ltd. held that the expression along with return of income occurring in Subsection (4) of Section 80 HHC of the Income Tax Act, 1961 is directory in nature insofar it relates to the time for furnishing of the report of an accountant by the assessee in the prescribed form; and even if such a report in the prescribed form is not furnished along with the return of income, but is furnished during the course of assessment proceedings, it cannot be removed out of consideration only for the reason of the same having not been filed at the initial stage of filing of the return.
- 2. On 29.01.2013, Hon'ble Division Bench in DB Income Tax Appeal No. 147/2007, Madhav Marbles & Granites Ltd. Vs. ACIT, Circle-2, Udaipur while deciding whether on the facts and in the circumstances of the case the turnover and profits/losses of the two Units being No. 1 and No. 3 could be clubbed together to determine the average profit/proportionate profits for the prupose of computing the deductions u/s. 80 HHC of Income Tax Act, 1961 held that the words "assessee being an Indian company or a person (other than a company) resident of India" is used in Section 80 HHC of the Act. The different units of the same assessee company engaged in manufacturing of different goods viz. Granite slabs and tiles in Unit-I and Marble slabs and tiles in Unit-III, does not make separate Units of the same assessee company as separate and different assessable units for the purposes of Section 80-HHC of the Act. The purpose of giving benefit of deduction

- **under Section 80-HHC is to encourage the exports** and profits derived by the assessee as such during the relevant year would form the basis for determining the extent of such deduction.
- 3. On 06.02.2013, Hon'ble Division Bench in DB Civil Writ Petition No. 4572/1998, Gopal Singh Vs. State of Rajasthan & Anr. held that under Section 19(6) of Rajasthan Imposition of Ceiling on Agriculture Holding Act, 1973 prescribing simple interest at the rate of two and half per cent per annum on the amount of compensation for acquiring surplus land under the Act of 1973 vis-a-vis higher rate of interest for compensation under other laws or under other transactions is a reasonable classification and a valid one. The difference of rate of interest is founded on intelligible differentia and has a rational relation with the object sought to be achieved by the Act of 1973. Hence, question does not arise of violation of the right of equality. The rate of interest as provided in Sub-section 19 of the Act of 1973 does not in any manner affects, offends or interferes with the basic structure of the Constitution of India nor is violative of the fundamental right of equality under Article 14 of the Constitution of India.
- 4. On 07.03.2013, Hon'ble Single Bench in S.B.Civil Writ Petition No.20133/2012, Phool Chand Vs. Rent Tribunal Baran & Others while discussing Section 9(j) of the Rajasthan Rent Control Act, 2001 held that if the word 'tenant' were to be literally and mechanically construed it is not difficult to visualise a situation where a tenant could through his family members such as his wife, unmarried sons and daughter own multiple properties and yet continue to invoke the protection of tenancy laws-Act of 2001- defeating its very purpose and object in seeking to strike a balance between the rights of a tenant and of the landlord. Lopsided mechanical protection of tenant was not the purpose of incorporating Section 9(j) into the 2001 Act. The provision in fact is for the protection of the landlord as the 2001 Act sought to balance the rights of the landlord and that of the tenant. Excessive protection to a tenant under the provisions of the Rajasthan Premises (Control of Rent and Eviction) Act, 1950 has been done away with the repeal of the said Act. Further the word "tenant" as defined in Section 2(i) of the 2001 Act is by itself subject to the caveat that definitions set out in Section 2 would be subject to the context. The definition of the "tenant" under Section 2(i) of the 2001 Act is thus not absolute and no drag on a purposive and contextual construction for including the spouse of the tenant unless disharmony and judicial separation of the two is established from the evidence on record.
- 5. On 13/3/2013, Hon'ble Single Bench in S.B.Civil Writ Petition No. 12284/2011 Ram Prakash Sharma vs. State of Raj. & ors. With 19 other connected matters, while directing the State Government to delineate,

demarcate and specify all the mining areas available for the **Sandstone and Masonry Stone** within a period of six months and renotify such delineated areas for grant of mining leases for sandstone and masonry stone held that **for allotment of mining leases under the MMCR**, **1986 the principle of `first come first served' is not permissible** and the pending applications for such allotment be considered by the State Government **as per the amended Rule 7(3) of the MMCR**, **1986 on the basis of lottery or by way of auction**, as may be considered appropriate by the State Government. The Hon'ble Court further held that upon quashing of **Sandstone Policy dated 24/7/2007** by the coordinate bench of this Court in **Deepak Khanna & 12 ors. vs. State of Rajasthan & ors. decided on 21/5/2009**, all the pending applications, including of those persons, who have not approached the Court, shall stand revived for fresh consideration for allotment of mining leases for sandstone and masnory stone by the State Government.

The Court quashed the fresh Policy decision Annex.11 dated 16/11/2011 and Annex.13 dated 28/11/2011 taken by the Mining Department after the said decision in Deepak Khanna's case and directed fresh decision on all pending applications applying the amended Rule 7(3) of the MMCR, 1986. The Court relied upon the famous 2G case in Centre of Public Litigation & Ors. vs. Union of India & ors. - (2012) 3 SCC 1 and its Presidential Reference under Article 143 of the Constitution of India in Natural Resources Allocation, In Re. Special Reference No. 1/2012 – (2012) 10 SCC 1, apart from other important decisions of Supreme Court and of this Court on the issue.


State & Ors. with 119 other connected matters, while discussing conflict between Article 16(2) and Article 15(3) of the Constitution of India if reservation to vulnerable class is provided held that Article 15(3) of the Constitution of India provides for affirmative action even in public employment. It may be even reservation in favour of women. The fact however cannot be ignored that Article 16(2) prohibits discrimination amongst citizens in public employment on the ground of sex and Article 16 (4) does not provide reservation in favour of women. The Constitutional Bench judgment in the case of Indra Sawhney has not approved reservation for women under Article 15(3) rather it is barred under Article 16(2). When specific provision exists in the Constitution to provide fundamental right to citizen in public employment, it cannot be subjected to other provision of the Constitution governing different field otherwise there would be conflict in two fundamental rights.
