**G.S.R.393**.-In exercise of the powers conferred by Sub-Section (1) of Section 28 of the Right to Information Act, 2005 the Chief Justice of Rajasthan High Court (Competent Authority) hereby makes following amendments in "Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006, namely:-

1. Short Title and Commencement. - (1) These Rules shall be called "Rajasthan Right to Information (High Court and Subordinate Courts) (Amendment) Rules, 2021".

(2) These amendments shall come into force from the date of their publication in the Official Gazette.

- 2. Amendment in Rule 7.- In Sub-rule (b) of Rule 7(1) of Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006, after the word Appellate Authority "." shall be inserted and the expression "by depositing fee Rs. 100/- in the shape of non-judicial adhesive stamp duly affixed or through Demand Draft/ Banker's Cheque in the name of Appellate Authority" shall be deleted.
- **3. Amendment in Form 'G'.-** Following Entry at Serial No. 9 in Form 'G' appended to Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006;
  - "9. A non-judicial stamp or Demand Draft/Banker's Cheque in the name of Appellate Authority, of Rs. 100/- has been affixed on/attached to the application."
