## ORDER

Pursuant to the Notice no. RHC/Exam. Cell/JPA/2020/104 dated 06.02.2020, following candidates declared successful in the recruitment to the post of Junior Personal Assistant, are hereby appointed as Junior Personal Assistant (Probationer Trainee) on the fixed remuneration of Rs. 23700/- per month initially for a period of two years from the date of joining as prescribed by the State Govt. vide its notification dated 30.10.2017, subject to following conditions:-

- Appointment on the post of Junior Personal Assistant is purely temporary in nature for a period of two years and the same will be extended further on the basis of work performance and conduct of the incumbent.
- No candidate shall be allowed to join service until he/she provides required documents/affidavits/certificates/NOC which was/were not submitted by the candidates at the time of documents verification held on 19.02.2020.
- Services of incumbent shall be liable to be terminated at any time without prior notice on the basis of statutory constraint/objection, if their services are not found satisfactory during the probation period of two years.
- Appointment of incumbent would be liable to be terminated without prior notice, if adverse report or concealment is found in the Police Verification of the candidates.
- No Annual Grade Increment, allowances and honorarium shall be allowed to incumbents during the Probation period.
- New Pension Scheme and New Medical Attendant Rules will be applicable on incumbents.
- 7. The incumbents must submit medical fitness certificate as prescribed in Rule 10 of Rajasthan Services Rules, 1951 at the time of joining.
- 8. Appointment of candidates on the post shall be subject to Character Verification through the Police.
- 9. This provisional appointment would be subject to verification of genuineness of documents for which incumbents have to produce their original testimonials alongwith one self attested photocopy set of all documents with one passport size photograph.
- 10. Incumbents are directed to join their duties at their place of posting on or before 17.03.2020 in the office of Registrar (Administration), Rajasthan High Court, Jodhpur / Jaipur Bench, Jaipur, failing which, their appointment order shall stand cancelled automatically without any further notice.

11. Pay of the probationer -trainees Junior Personal Assistant will be fixed in the Pay Matrix Level-10 (33800-106700) after successful completion of probation-trainee period and they will be entitled to get other allowances as per rules.
