conditions :-

- 1. Appointment on the post of Chauffeur is subject to the any writ petition pending or file in future before Hon'ble High Court.
- 2. Appointment on the post of Chauffeur is purely temporary in nature for a period of two years and the same will be extended further on the basis of work performance and conduct of the incumbent.
- 3. No candidate shall be allowed to join service until he / she provides required documents / affidavit / certificates which was / were not submitted by the candidates at the time of applying / interview.
- 4. Services of incumbent shall be liable to be terminated at any time without prior notice on the basis of statutory constraint / objection, if their services are not found satisfactory during the probation period of two years.
- 5. Appointment of incumbent would be liable to be terminated without prior notice, if adverse report or concealment of any relevant fact(s) is found in the Police verification of the candidates.
- 6. No Annual Grade Increment, allowances and honorarium shall be allowed to incumbents during the probation period.
- 7. The incumbents must submit medical fitness certificate as prescribed in Rule 10 of Rajasthan Services Rules, 1951 at the time of joining.
- 8. The incumbents must submit last Institution Character Certificate issued by the Principal / Academic Officer of the University, College or School.
- 9. The incumbents must submit two Character Certificate issued by the responsible person (Separately) not connected with University, College or School and not related to him which is not more than six months old.
- 10. The incumbents must submit marriage certificate or affidavit in support of their marital status with number of children supported by necessary proof.
- 11. The incumbents must submit Certificate or affidavit regarding conviction / acquittal from any Court of Law in India.
- 12. Appointment of candidates on the post shall be subject to Character Verification through Police.
- 13. This provisional Appointment would be subject to verification of documents for which incumbents have to produce their original testimonials alongwith one self attested photo copy set of all documents with one passport size photograph.
- 14. - 16. They will not get T.A. and joining time for this appointment.
