WHEREAS, disciplinary proceedings under Rule 16 of the Rajasthan Civil Services (Classification, Control and Appeal) Rules, 1958 is under contemplation against Smt. Vandana Sharma, an officer in Civil Judge Cadre, presently posted as Civil Judge & Judicial Magistrate, Asind, Bhilwara.

NOW, THEREFORE, Hon'ble the Chief Justice, in exercise of the powers conferred by Rule 13 of the Rajasthan Civil Services (Classification, Control and Appeal) Rules, 1958 read with Full Court Resolution dated October 30, 1971 hereby places said Smt. Vandana Sharma under suspension with immediate effect.

During the period of suspension, Smt. Vandana Sharma, Civil Judge & Judicial Magistrate, Asind, Bhilwara shall be paid subsistence allowance as per Rules, and her headquarters during the period of suspension will be in Rajasthan High Court at Jodhpur.
