- 5. No Annual Grade Increment, allowances and honorarium shall be allowed to incumbents during the probation period.

10 of Rajasthan Services Rules, 1951 at the time of joining.

- 7. Incumbents are directed to join their duties at their place of posting on or before 25.10.2024 in the office of Registrar (Administration), Rajasthan High Court, Jodhpur / Jaipur Bench, Jaipur failing which, their appointment order shall stand canceled automatically without any further notice.
- 8. Pay of the probationer trainee Reference Assistant and Library Restorer will be fixed in the pay Matrix Level- 05 (20800-65900) after successful completion of probation period and they will be entitled to get other allowances as per rules.
- 9. They will not get T.A. and joining time for this appointment.
