Constitution of India, Hon'ble the Chief Justice of the High Court of Judicature for Rajasthan, hereby makes the following rules further to assend the Rajasthan High Court Staff Service Rules, 2002, namely:-

- L Short tille and commencement.
- (i) These Rules may be called the Rajasthan High Court Staff Service (Amendment) Rules, 2019.
- (a) They shall come into force with immediate effect.
- 2. Amendment in Rule 14:- The existing sub rule 8 of Rule 14 of the said rules shall be substituted by the following, namely:-

\*14(3) Reservation for Economically Weaker Sections.-

Reservation of vacancies for Economically Weaker Sections shall be 10% in direct recruitment in addition to the existing necessarion in the event of non-availability of eligible and suitable cancidate amongst Economically Weaker Sections in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure.

bugiannian:

For the purpose of this rule 'Economically Weaker Sections' shall be the persons who are bonafide resident of Rajasthan and not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes, the Backward Classes, the More Backward Classes and whose family has gross annual income below rupees 8.00 lakh. Family for this purpose will include the persons who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application."
