Whereas, Shri Ramji Lai Chaura, Advocate (R/1804/2010) was appointed as Oath Commissioner under Rule 33 of Rajasthan High Court Rules, 1952, for the Calendar Year-2019 for Rajasthan High-Court, Jaipur Bench, Jaipur vide Misc. Order No.11 dated 6/12/2018.

And whereas, in the matter of D.B. Civil Misc. Appeal No. 2082/2019, Ms. Bhawna Anand Vs Rahil Kumar Jawa, vide order dated 27.08.2019, Honfble Rajasthan High Court, Bench at Jaipur has noted a clear finding, after affording opportunity of hearing to Shri Chaura, that he attested the affidavit in absence of the deponent and directed the Registrar (Judicial) Jaipur Bench, Jaipur to conduct enquiry under Section 340 Cr.P.C. as to why he should not be proceeded for the offence of perjury. Hon'ble Court further directed to initiate proceedings for cancellation of his license as Oath Commissioner.

And whereas, in above enquiry under Section 340 Cr.P.C., after taking explanation of Shri Chaura, the Registrar (Judicial) has submitted report before Hon'ble Court whereupon after affording opportunity of hearing to Shri Chaura, Hon'ble Court directed the Registrar (Judicial) to file a criminal complaint against him.

On thorough examination of the matter and taking note that Shri Ramiji Lai Chaura has aiready been given ample opportunity of hearing, it was found that the act and conduct of Shri Ramji Lai Chaura are unbecoming of an Oath Commissioner, therefore, Shri Ramji Lal Chaura (R/1804/2010) is hereby removed from the panel of Oath Commissioner u/r 39 of Rajasthan High Court Rules 1952 with Immediate effect.
