- The selection of the candidates recommended for appointment for the establishment of Rajasthan High Court is provisional and subject to verification of required documents and inquiry by Appointing Authority.
- 5. Wherever, the required numbers of eligible widow candidates were not available, the shortfall has been made up by divorcee candidates in conformity with Rule 14 (3) of the Rajasthan High Court Staff Service Rules, 2002.
- Wherever, the required number(s) of eligible women candidates found place in the respective categories, no separate cut off for women candidates is being declared.
- 7. The merit of the candidates securing equal marks in Shorthand Speed Assessment Test has firstly been determined on the basis of higher marks obtained in the Shorthand Test and in case, the candidates secure equal marks even in the Shorthand Test, the merit has been determined having regard to 'Age' of the candidates i.e. the candidate, elder in age has been given higher place in merit.
- 8. On account of a pause during dictation of examination dated 15.05.2024 in the Academic Block, the speed and marks have been

calculated by assuming total dictated words as 554 and the maximum prescribed time as 7.914285714 minutes.

### Part-II

- vi. Admit Card presented at the time of Shorthand Speed Assessment Test duly stamped at the time of biometric verification.
