RECRUITMENT BY PROMOTION TO THE CADRE OF DISTRICT JUDGE, 2020 THROUGH LIMITED COMPETITIVE EXAMINATION

On-line Applications are invited in the prescribed format from the eligible Senior Civil Judges under Rule 32(4) of Rajasthan Judicial Service Rules, 2010 (as amended from time to time) for recruitment by promotion on total 17 posts (16 posts for the year 2020-21 and 01 post for the year 2019-2020) to the cadre of District Judge through Limited Competitive Examination to be conducted by this Court.

The Senior Civil Judges, who have completed actual five years service as on the 1st day of January, 2021 shall be eligible for appearing in the Limited Competitive Examination for promotion to the cadre of District Judge [As per Rule 32(3) of RJS Rules,2010]

The candidates are advised to carefully read RJS Rules, 2010 (as amended from time to time), instructions for filling On-line Application and Scheme & Syllabus of Limited Competitive Examination for promotion to the Cadre of District Judge before filling On-line Application available on web-site of Rajasthan High Court (<u>http://www.hcraj.nic.in</u>).

On-line Application can be filled-in by the candidate himself/herself through his/her own computer with internet facility or any other Agency (Cyber Cafe etc.).

Notes:

- Candidates should take a print-out of blank format of On-line application form available at the above mentioned website and fill it manually. After ensuring that all the require information filled-in correctly, he/she should start filling-in on-line application to avoid probability of any error.
- 2. The instructions for filling-in online application form will be uploaded on the official website of Rajasthan High Court, well in time. The candidates are advised to go through carefully with the instructions before filling-in online application form and also advised to visit regularly the official website of Rajasthan High Court.
- 3. The on-line application form, once submitted by clicking "Save" button, shall not be open for any kind of change/amendment/editing. The candidate shall be responsible for the consequences arising there from.

No application shall be entertained for any kind of change/amendment in the entries of on-line application. The candidates are, therefore, advised to ensure before clicking on the "Save" button that all the information have been filled-in correctly in the relevant columns.

- 4. On-line applications shall only be accepted. Neither any documents nor hard copy of application are required to be remitted personally or through post by the eligible candidates to this Court.
- 5. List of eligible Senior Civil Judges will be uploaded on the official web-site of Rajasthan High Court, well in time. Only eligible Senior Civil Judges enlisted by this Court can submit On-line Application.

SCHEME OF EXAMINATION

(a) The scheme of the Written Examination for Limited Competitive Examination for promotion to the Cadre of District Judge shall consist of subjective/narrative type questions, comprising of four Papers of 100 marks, each. The duration of each Paper will be of 03 hours (180 minutes). A candidate shall be required to secure minimum prescribed marks to be declared successful.

(b) Interview: The interview shall be of 50 marks. In interviewing a candidate, suitability for promotion to the District Judge Cadre shall be tested with reference to his service record and his character, personality, address and physique. Question which may be put to him may be of a general nature and will not necessarily be academic or legal. The candidate will also be put questions to test his general knowledge including knowledge of current affairs and present day problems. The marks so awarded shall be added to the marks obtained by each candidate in the written examination.

(c) it shall be compulsory to appear, in each and every paper of Written Examination, as also before the Interview Board for viva voce. A candidate, who has failed to appear in any of the written paper or before the board for viva voce shall not be recommended for promotion.

Syllabus for Written Examination

Syllabus for Written Examination is prescribed in Schedule X of the "Rules".

Important Dates

The link for submission of online application form be activated at 01.00 pm on 27.01.2021 (Wednesday) and shall remain active up to 05.00 pm on 27.02.2021 (Saturday).

Candidates must furnish all the relevant information required in the on-line application. Furnishing of false and/or incomplete information shall lead his application to rejection for which he/she himself/herself will be solely responsible.
