4. **Certificate of Disability** issued by competent authority as per relevant rules.
5. **Certificate of Employment and No Objection Certificate** (for employees of Rajasthan State Government/ Panchayat Samiti / Zila Parishad/ PSUs/Corporations).
6. **Certificate of date of Birth** – Birth Certificate or Certificate of Secondary/Higher Secondary/Senior Secondary School, with date of Birth issued by recognised Board of Education.
7. Secondary School Certificate and Mark Sheet.
8. Hr. Sec./Sr. Sec. School Certificate and Mark Sheet.
9. Graduation – Degree and Mark Sheets.
10. Bachelor of Laws (Professional) – Degree and Mark Sheets.
11. Certificate/Document of higher education, **if any.**
12. Proof of dismissal/removal/termination by previous employer, **if any.**
13. Proof of conviction for any offence involving moral turpitude and permanently debarred or disqualified from appearing in any examination, **if any.**
14. Proof of Professional Misconduct, if being an Advocate found guilty of Professional Misconduct under the provisions of Advocates Act, 1961, **if any.**
15. Proof of Criminal Prosecution pending against you, **if any.**
16. Proof of conviction by Criminal Court, **if any.**

NOTE :-

1. In absence of original documents, the candidate shall not be allowed to appear in the interview and the candidature of such candidate shall be rejected.
2. Please note that no request for any change in the date, time and venue for the interview will be entertained. In case, you fail to appear for the interview as per the above schedule, your candidature for the recruitment shall be rejected.
3. The candidature of the candidate shall be rejected in case he/she fails to bring required original documents.
4. Further, if you try to influence the Recruiting Authority in any way, you may be disqualified for recruitment.
5. No TA/DA or any other allowance will be admissible to you for the journey undertaken and no attendance certificate shall be issued for attending the Interview.
