In continuation to the earlier Notice No. RHC/Exam. Cell/DJC/2020/2470 Dated: 01.10.2022, it is **NOTIFIED** to all concerned that interview of the candidates, who were provisionally qualified to be called for Interview, for the direct recruitment to the Cadre of District Judge, 2020, shall be held at **Rajasthan State Judicial Academy, Near Jhalamand Circle, Old Pali Road, Jodhpur (Rajasthan)** on **14.11.2022**. As per Roll Numbers allotted to the candidates for the Main Examination of the direct recruitment to the Cadre of District Judge, 2020, the Time Schedule for interviews is as under:

The candidates are required to remain present for Interview on the date and reporting time mentioned above in the temporary office of **Registrar (Examination), at Rajasthan State Judicial Academy, Jodhpur, Near Jhalamand Circle, Old Pali Road, Jodhpur (Rajasthan)** with their original documents/certificates for verification. The candidates are **directed to bring all the following original documents** along with two attested/certified photo copies of each document:-

- a) **Caste Certificate**: Candidates belonging to SC, ST, OBC (NCL), MBC (NCL) or EWS shall have to produce original caste certificate for claiming benefit of reservation in prescribed format duly issued by the competent authority. In case the candidate belongs to OBC (NCL), MBC (NCL) or EWS has to submit certificate not prior to one year from the last date of submission of application form.
- b) **Character and length of actual practice Certificate**: Original Certificate from District Judge concerned/ Registrar of concerned High Court/Supreme Court in the prescribed format (with Seal of the concerned Authority) regarding character and length of actual practice of candidate; (In case, original certificate is not submitted, yet)
- c) **Birth Certificate and Certificates of Educational Qualifications**:
  - Original secondary/equivalent, School certificate/any other educational document having date of birth;
  - Original Bachelor of Law (professional) Degree;
  - Original Enrolment Certificate/Sanad;
  - Original degree/certificate of any other educational qualification, if any
- d) **NOC (In case of candidate is in service)**: Original 'No Objection Certificate' of Department for appearing in the examination and proof of length of service (if any);

e) Certificates regarding disqualifications, if any:

- Attested copy (ies) of document relating to Dismissal/ Removal/Termination (if any);
- Certified copy(ies) of Judgement/Order relating to conviction or acquittal (if any);
- Certified copy(ies) of registered FIR (if any);
- Certified copy(ies) of Charge-sheet filed in a Court of Law (if any);
- Certified copy(ies) of negative final report filed in a Court of Law and order passed thereon regarding acceptance/rejection/present status, if any;
- Attested copy(ies) of Order relating to permanently Debarring/Disqualifying from appearing in any Examination or Interview (if any);
- Attested copy(ies) of Order relating to Professional Misconduct under Advocates Act, 1961 or any other Law for time being in force (if any);
- Conviction for any offence involving moral turpitude by a Court of Law, if any;
- Acquittal for any offence involving moral turpitude or any other offence by a Court of Law, if any;
- Any criminal prosecution pending against you, if any;
- more than two children on/or after the date of commencement of RJS Rules, 2010 subject to proviso & explanation of Rule 12 of RJS, Rules, 2010.

f) Marriage Registration Certificate or Affidavit, as the case may be, if applicable.

g) **Original Character Certificates (If all or any original certificate is not submitted, yet)**: 03 Character Certificates (one issued by the Principal Academic Officer of the University or College in which he has last educated, and two, from responsible persons not related to his/her University, College or School, issued not more than six months prior to the date of the online application form).

h) **Affidavit (If Affidavit is not submitted, yet)**: Affidavit to this effect that he has not accepted/will not accept dowry in his marriage.

i) **Proof of identity and Photograph**: one of the original recognised photo ID proof (Aadhar Card(Unique ID)/Voter ID/PAN Card/Driving Licence/Passport) and two recent Passport size coloured Photographs.

j) **Certificate of Bonafide Resident of Rajasthan**: The candidates seeking reservation in any category may be asked to furnish certificate of Bonafide Resident of Rajasthan.


**Notes-**

- a. You are also directed to wear face mask, maintain social distancing and follow guideline of Central /State Government issued regarding COVID – 19 while appearing for the interview.

- b. Please note that no request for any change in the date, time and venue for the interview will be entertained. In case, you fail to appear for the interview as per the above schedule, your candidature for the recruitment shall be rejected.
- c. If you try to influence the Recruiting Authority in any way, you may be disqualified for recruitment.
- d. No TA/DA or any other allowance will be admissible to you for the journey undertaken and no attendance certificate shall be issued for attending the Interview. In case of any clarification/query, you may contact on 0291-2888100, 2888101.
