
### **Notes-**

1. The candidature of the candidates, declared provisionally qualified, is liable to be rejected at any stage, in case the original documents to be produced, do not fulfil the requirement of eligibility as per the provisions contained in the Rajasthan High Court Staff Service Rules, 2002.
2. Due to the non availability of the required number of eligible and suitable candidates of OBC-NCL category, the unfilled

vacancy so reserved, has been filled in accordance with the normal procedure, as provided in the Rajasthan High Court Staff Service Rules, 2002.

3. The unfilled vacancies of Scheduled Caste Category and Scheduled Tribes Category are not filled by normal procedure as no provisionally qualified candidate is available in the Unreserved Category.
4. The result is prepared, relaxing the required aggregate marks from 60% to 55%.
5. The result is prepared keeping in view that if two or more non Law Graduate candidates secured equal aggregate marks then preference is given to older in age; if two or more Law Graduate candidates secured equal aggregate marks then preference is given to older in age and if two or more candidates (one law graduate and other non law graduate) secure equal aggregate marks then preference is given to law graduate.
