

NOTICE

Pursuant to advertisement No. RHC/ExamCell/Sub.Court/Stenographer/2020/17 dated 18.01.2020, the result of Shorthand Test & Computer Test for joint recruitment to the post of Stenographer Grade-III (Hindi & English) for District Courts and Stenographers for District Legal Services Authorities (DLSAs) & Permanent Lok Adalats (PLAs), 2020 was declared vide Notice dated 30.06.2021 and after interview, final result was declared vide Notice dated 31.07.2021.

Many representations were received & Writ Petitions were filed wherein some technical issues in software of result process were alleged, therefore, Rajasthan High Court examined the software and it was found that due to inadvertence, while preparing the result on earlier occasion software/agency did not give effect of mistakes committed by the candidates and marks were awarded only on the basis of correct words typed. Apart from above, some other discrepancies were noticed, due to which a decision was taken to cancel the earlier results dated 30.06.2021 & 31.07.2021.

In the above factual backdrop, it is **Notified** to all concerned that While cancelling the result dated 30.06.2021 & 31.07.2021, the revised result of Shorthand Test & Computer Test is hereby published (As permitted by Hon'ble Rajasthan High Court vide its order dated 25.10.2021).
