

The Written Examination is likely to be held at Jodhpur. The information regarding examination centres and date of the examination shall be published on the official web-site of Rajasthan High Court.

Applications shall be submitted by hand by the applicant, from 09.10.2018 to **24.10.2018** in the office of Registrar (Examination), Rajasthan High Court, Jodhpur/Bench, Jaipur during the office hours, with full details regarding educational qualification and service particulars etc.

**IMPORTANT NOTE:-**

1. Employee, who had applied earlier and found eligible, in pursuance of earlier Notification No. Estt/Hc/2015/150 dated 16.04.2015, need not to apply again.
2. List of above eligible employees is being uploaded with the Notification on the official website of the Court.
3. Appointments to be made, shall be subject to final outcome of the Civil Appeal No. 2634/2013, Tej Prakash Pathak & Ors. v/s Rajasthan High Court & Ors., pending before Hon'ble Supreme Court of India.
