

Candidates are **directed to bring all the original documents** along with two attested/certified photo copies of each document pertaining to their Educational Qualifications, Age, Caste/Category, three Character Certificates (One issued by the Principal Academic Officer of the University or College in which he/she was last educated; and two from responsible persons, issued not more than six months prior to the date of the application), one of the recognised Photo ID Proof to establish their identity along with two coloured passport size Photographs and any other such document(s) which they want to rely upon to claim any concession/benefit/ reservation such as Disability Certificate, Certificate of Rajasthan Govt. Employee with No Objection Certificate of the Department, Certificate of Bona-fide Resident of Rajasthan, Death

Certificate of Husband (in case of Widow), Proof of Divorce (in case of Divorcee).

Candidates are also directed to bring Marriage Certificate, if he/she is married. Male candidates are required to produce an affidavit to this effect that he had not accepted/shall not accept dowry at his marriage.


Further, the candidates are directed to produce the proof, if any, of Criminal Prosecution pending against him/her and/or Conviction by the Criminal Court. Candidates shall also produce the proof of dismissal/removal/termination by previous employer, if any; proof of conviction for any offence involving moral turpitude and permanently debarred or disqualified from appearing in any examination, if any; and proof of Professional Misconduct by an Advocate under the provisions of Advocates Act, 1961, if any.

Please note **that no request for any change in the date, time and place for the interview will be entertained.** In case, any of the candidates fails to appear for the interview as per the above schedule, his/her candidature for the recruitment is liable to be rejected.

No TA-DA or any other allowance will be admissible to the candidates for the journey undertaken and no Attendance Certificate shall be issued for attending the Interview.

The call letters are being sent to candidates regarding his/her schedule of the interview by Registered Post on the address provided by them in the on-line Application. **They are, however, directed to appear in the interview as per the above schedule with required documents, even if the registered post does not reach them in time.**
