The candidates are required to remain present for Interview on the date and reporting time mentioned above in the temporary office of **Registrar (Examination), at Rajasthan State Judicial Academy, Jodhpur, Near Jhalamand Circle, Old Pali Road, Jodhpur (Rajasthan)** with their original documents/certificates for verification. The candidates are **directed to bring all the following original documents** along with two attested/certified photo copies of each document: for verification/perusal. In the absence of original documents, you shall not be allowed to appear in interview and your candidature shall be rejected:

1. Certificate of date of Birth – Birth Certificate or Certificate of Secondary/Higher Secondary/Senior Secondary School having date of Birth issued by recognised Board of Education.
2. Secondary Certificate and Mark Sheet.
3. Hr. Sec./Sr. Sec. Certificate and Mark Sheet.
4. Graduation – Degree and Mark Sheets.
5. Bachelor of Laws (Professional) – Degree and Mark Sheets.
6. Certificate/Document of higher education, if any.
7. Certificate required for seeking reservation in any of the categories – SC/ST/OBC-NCL/MBC-NCL/EWS of Rajasthan.
Caste Certificate of OBC/MBC (Non Creamy layer) must have not been issued prior to one year from the last date of submission of the online application from i.e. 08.05.2024 and in case of OBC/MBC NCL Certificate is issued between 09.05.2021 & 08.05.2023, an affidavit in prescribed format along with caste certificate has to be produced.
In case of EWS Category, Income and Asset Certificate must have not been issued prior to 01.04.2024 and in case Income and Asset Certificate is issued between 01.04.2022 & 31.03.2024, an affidavit in prescribed format along with Income & Asset certificate has to be produced.
8. SC/ST/OBC-NCL/MBC-NCL/EWS certificate must not have been issued after the last date of submission of the application form i.e. 08.05.2024.
9. Marriage Registration Certificate/Affidavit, as the case may be.
10. Documents related to Divorce (Certified copy of Judgement/Decree, in case of Divorcee)
11. Death Certificate of Husband (in case of Widow)
12. Certificate of Disability issued by competent authority as per relevant rules.
13. Certificate of Ex-servicemen issued by competent authority.
14. Certificate of Employment and No Objection Certificate (for employees of Rajasthan State Government/ Panchayat Samiti / Zila Parishad/ PSUs/ Corporations)
15. Documents related to:-

- i. Dismissal/removal/termination by previous employer, if any;
 - ii. Conviction for any offence involving moral turpitude by a Court of Law, if any;
 - iii. Conviction for any offence other than involving moral turpitude by a Court of Law, if any;
 - iv. Acquittal for any offence involving moral turpitude or any other offence by a Court of Law, if any;
 - v. Criminal Prosecution pending against you, if any;
 - vi. Any charge sheet for committing any offence has ever been filed against you in the Court of Law;
 - vii. Negative Final Report concerning you has ever been filed against you in the Court of Law, if any;
 - viii. Professional Misconduct by an Advocate under the provisions of Advocates Act, 1961, if any;
 - ix. Permanently debarred or disqualified from appearing in any examination, if any;
 - x. More than two children on/or after the date of commencement of RJS Rules, 2010 subject to proviso and explanation of Rule 12 of RJS Rules, 2010.
16. Three Character Certificates (one issued by the Principal Academic Officer of the University or College in which you were last educated, and two, from responsible persons not related to you, issued not more than six months prior to the date of application).
 17. Affidavit to this effect that you had not accepted/will not accept dowry in/at your marriage.
 18. Affidavit regarding not having more than one spouse.
 19. Recognised Original photo ID proof (same as uploaded in the online application form).
 20. Two recent Passport size coloured Photographs.
 21. Certificate of Bonafide Resident of Rajasthan, if seeking reservation in any category.

Notes:-

- i. Please note that no request for any change in the date, time and venue for the Interview will be entertained. In case, you fail to appear for the Interview as per the above schedule, your candidature for the recruitment shall be rejected.
- ii. Further, if you try to influence the Recruiting Authority in any way, you may be disqualified for recruitment.
- iii. No TA/DA or any other allowance will be admissible to you for the journey undertaken and no attendance certificate shall be issued for attending the Interview. In case of any clarification/query, you may contact on 0291-2888100, 2888101.
- iv. DRESS CODE:
