The candidates are required to remain present for Interview on the date and reporting time mentioned above in the temporary office of Registrar (Examination), at Rajasthan State Judicial Academy, Jodhpur, Near Jhalamand Circle, Old Pali Road, Jodhpur (Rajasthan) with their original documents/certificates for verification. The candidates are directed to bring all the following original documents along with two attested/certified photo copies of each document:-

- Birth Certificate: birth certificate or certificate of Secondary/Higher Secondary/Senior Secondary School with date of Birth issued by recognized Board of Education;
- ii. <u>Certificate of Educational Qualification</u>:- Certificates and Mark Sheet of Secondary, Hr. Sec./Sr. Sec. School Certificate issued by recognized Board of Education and Degree & Mark Sheets of Graduation & Bachelor of Laws (Professional) issued by recognized Board/University/Council or certificate/document of higher education, if any.

iii. Certificate relating to category:-

- a. OBC/MBC (Non Creamy layer) certificate issued not prior to one year from the last date of submission of the application form i.e. 31.08.2021.
- b. In case OBC/MBC (Non Creamy Layer) certificate is issued between 31.08.2018 and 30.08.2020, an affidavit in prescribed format along with caste certificate has to be produced.
- c. In case of EWS category Income & Asset Certificate required for seeking reservation in EWS category must not be issued prior to 01.04.2021.
 - In case Income & Asset Certificate issued between 01.04.2019 and 31.03.2021, an affidavit in prescribed format along with certificate has to be produced.
- d. SC/ST/OBC/MBC/EWS certificate, as the case may be must not have been issued after the last date of submission of the application form i.e. 31.08.2021.

- iv. Marriage Registration Certificate/Affidavit as the case may be.
- v. <u>Documents relating to divorcee and widow</u>:- Death Certificate of husband issued by competent authority, in case of Widow and proof of Divorce (Certified copy of Judgment/Decree issued by the court of competent jurisdiction), in case of Divorcee.
- vi. <u>Certificate relating to disability</u>:- Certificate of Disability issued by competent authority as per relevant rules, if applicable.
- vii. No objection certificate:- Employees of Rajasthan State Government/Zila Parishad/PUCs/ Corporations/ Panchayat Samiti are required to furnish certificate of employment in substantive capacity and No Objection Certificate, issued by his/her department, for appearing in Civil Judge Cadre Examination, 2021.
- viii. <u>Certificates regarding disqualifications for appointment</u>:- The candidates are directed to submit document(s) related to -
 - a. Dismissal/ removal/ termination by previous employer, if any;
 - b. Conviction for any offence involving moral turpitude by a Court of Law, if any;
 - c. Conviction for any offence other than involving moral turpitude by a Court of Law, if any;
 - d. Acquittal for any offence involving moral turpitude or any other offence by a Court of Law, if any;
 - e. Any criminal prosecution pending against you, if any;
 - f. Any charge sheet for committing any offence has ever been filed against you in the Court of Law;
 - g. Any negative Final Report concerning you has ever been filed in the Court of Law, if any;
 - h. Professional Misconduct by an Advocate under the provisions of Advocates Act, 1961, if any;
 - i. Permanently debarred or disqualified from appearing in any examination, if any.
 - ix. <u>Character Certificates</u>:- Three Character Certificates (one issued by the Principal Academic Officer of the University or College in which he/she has last educated, and two, from responsible persons not related to his/her University, College or School, issued not more than six months prior to the date of the online application form).
 - x. Affidavit:- Affidavit to this effect that he/she has not accepted/will not accept dowry in his/her marriage.

- xi. <u>Proof of identity and Photograph</u>:- One of the recognized photo ID proof (Aadhar Card(Unique ID)/Voter ID/PAN Card/Driving Licence/Passport) and two recent Passport size coloured Photographs.
- xii. <u>Certificate of Bonafide Resident of Rajasthan</u>:-, The candidates seeking reservation in any category are directed to furnish certificate of Bonafide Resident of Rajasthan.

NOTES:-

- Candidates are directed to wear face mask, maintain social distancing and follow guidelines of Central/State Government issued regarding COVID-19 while appearing for the interview.
- 2. In absence of required original documents, the candidate shall not be allowed to appear in the interview and the candidature of such candidate shall be rejected.
- No request for any change in the date, time and venue for the interview will be entertained. In case, any candidate fail to appear for the interview as per the above schedule, his/her candidature for the recruitment shall be rejected.
- 4. Further, if any candidate try to influence the Recruiting Authority in any manner, he/she may be disqualified for recruitment.
- No TA/DA or any other allowance will be admissible for the journey undertaken and no attendance certificate shall be issued for attending the Interview.
