1. Certificate required for seeking reservation in any of the categories – SC/ST/OBC/MBC/EWS of Rajasthan. OBC/MBC (Non Creamy layer) Certificate must not have been issued prior to one year from the last date of submission of the application.
2. Proof of defence Service personnel/ outstanding sports person
3. Marriage Registration Certificate/Affidavit as the case may be.
4. Death Certificate of Husband (in case of Widow)
5. Proof of Divorce (Certified copy of Judgement/Decree, in case of Divorcee)
6. Certificate of Disability issued by competent authority as per relevant rules.
7. Certificate of Employment and No Objection Certificate(for employees of Rajasthan State Government/ Panchayat Samiti / Zila Parishad/ PUCs/ Corporations)
8. Birth Certificate or Certificate of Secondary/Higher Secondary/Senior Secondary School with date of Birth issued by recognised Board of Education
9. Secondary Certificate and Mark Sheet.
10. Higher Secondary/Senior Secondary Certificate and Mark Sheet.


11. Certificate relating to Computer Qualification
12. Certificate/Document of higher education, if any.
13. Three Character Certificates (one issued by the Principal Academic Officer of the School, University or College in which you were last educated, and two, from responsible persons not related to you, issued not more than six months prior to the date of the application).
14. Affidavit to this effect that you had not accepted/will not accept dowry in/at your marriage
15. One of the recognised photo ID proof (Aadhar Card(Unique ID)/Voter ID/PAN Card/Driving Licence/Passport).
16. Two Passport size coloured Photos.
17. Certificate of Bonafide Resident of Rajasthan, if seeking reservation in any category.

Please note that no request for any change in the date, time and place of interview will be entertained. In case, any of the candidates fails to appear for the Interview as per the above schedule, his/her candidature for the recruitment is liable to be rejected.

No TA-DA or any other allowance will be admissible to the candidates for the journey undertaken and no attendance certificate shall be issued for appearing in the interview.

The Call Letters for Interview are being sent through Speed/Registered Post AD to all the candidates, similarly Call Letters are being e-mailed on their registered e-mail address, as mentioned in their online application form. However, they are directed to appear in the Interview as per the above schedule, even if the Call Letter does not reach them in time.
