It is notified to all concerned that list of common filing defects is available and uploaded on official website of Rajasthan High Court for information of lawyers/litigants. Before filing of a case, the lawyers/litigants are required to ensure that a case is filed without defects.

As soon as the defects are notified, the defects should be removed within seven days in the Defect Section. If the defects are not removed within seven days of the notification of defects, cases will be listed before the Registrar(Admn.), where the defects are either to be removed or lawyers/litigants may satisfy the Registrar (Admn.) that defects have been removed. In all other cases in which defects have not been removed, the Registrar (Admn.) shall proceed to pass orders in exercise of its powers conferred under Chapter II of the Rajasthan High Court Rules, 1952 read with Notification No. S.O.03/2006, dated 12.05.2006.

If any mentioning is made for urgent listing before the Hon'ble Court in any case, where defect has been notified to the lawyer/litigant and where either defect has not been removed/not removed even after time granted/prayer for overruling, condoning, exempting defect has been rejected by the Registrar (Admn.), same shall be clearly mentioned in the Mentioning Form.

All mentioning shall be made strictly as per the proforma of mentioning form attached with this notification and if defect has been notified to lawyers/litigants in the Registration Number, 'D' shall be mentioned.

Mentioning for constitution of any Special Bench shall be made only before Hon'ble the Chief Justice. If Special Bench has already been constituted, mentioning for listing the case shall be made before the Special Bench. If the Special Division Bench is not available, mentioning for listing shall be made before the Senior Judge of Division Bench.
