STANDING ORDER

In supersession of this office Standing Orders No. 40/S.O./2023 dated 22.12.2023 & 18/S.O./2024 dated 01.07.2024 and pursuant to the observations made by Hon'ble Supreme Court of India in order dated 07.02.2025 passed in **Shekhar Prasad Mahto @ Shekhar Kushwaha Vs The Registrar General, Jharkhand High Court & anr Writ Petition (Criminal) No. 55/2025**, it is enjoined upon all concerned that whenever roster for hearing bail applications is assigned to more than one Single Benches, all bail applications arising out of the same FIR shall be placed before one Hon'ble Bench, subject to following conditions :-


(i) if a bail application of a particular accused has been **decided**, whether on merit or withdrawal or not pressed (excluding interim or temporary bail without consideration of merit), **subsequent bail application/s** of that particular accused shall be listed before the **same** Hon'ble Judge who had passed the earlier order/(s) on previous bail application of the same accused.

(ii) if roster for hearing bail applications is assigned to more than one Single Benches and any previous bail application/s in the same F.I.R has been decided, whether on merit or withdrawal or not pressed (excluding interim or temporary bail without consideration of merit), by any one Hon'ble Judge **having roster for hearing bail applications**, then **first bail applications** of other co-accused in the same F.I.R. shall be listed before the **same Hon'ble Judge** who has earlier **decided** bail application/s in the same F.I.R.

(iii) if roster for hearing bail applications is assigned to more than one Single Benches and previous bail applications in the same F.I.R have been decided, whether on merit or withdrawal or not pressed (excluding interim or temporary bail without consideration of merit) by more than one Hon'ble Judges **having roster for hearing bail applications**, then **first bail applications** of other co-accused in the same F.I.R. shall be listed before such Hon'ble Judge who **decided** bail application in the same F.I.R. **earlier in point of time**.

This order will be applicable at Principal Seat of High Court of Judicature for Rajasthan at Jodhpur as well as Bench at Jaipur.
