## STANDING ORDER

No. 13/S.O./2024

It has been observed by Hon'ble Rajasthan High Court, Bench Jaipur in order dated 19.12.2023 passed in D.B. Criminal Reference No. 1/2023 (Pooja Gurjar & Ors. vs. State of Rajasthan), that neither the statute directs impleadment of victim as a party-respondent nor the judgment of Jagjeet Singh & Ors. vs. Ashish Mishra @ Monu & Anr. (Judgment dated 18.04.2022 passed in Criminal Appeal No.632 of 2022) directs impleadment of victim as a necessary party. Jagjeet Singh & Ors. case only provides that the victim has a vested right to be heard at every stage of proceedings. Therefore, the victim is not a necessary party and is not required to be impleaded as party-respondent in bail applications under Sections 437, 438 or 439 of Code of Criminal Procedure.

In view of the above, it is enjoined upon all concerned that mandate of the Hon'ble Court be strictly comply with.
