## HON'BLE MRS. JUSTICE SHUBHA MEHTA

## Order

## 11/07/2023

निगरानीकार-अभियुक्त की ओर से यह पुनरीक्षण याचिका विद्धान विचारण न्यायालय, अतिरिक्त मुख्य न्यायिक मजिस्ट्रेट, संख्या-एक, केकडी जिला अजमेर द्वारा आपराधिक नियमित प्रकरण संख्या-17/2015 में पारित निर्णय दिनांकित 24.082018 जिसके द्वारा निगरानीकार-अभियुक्त को धारा 138 परकाम्या लिखत अधिनियम में दोषी करार देते हुए दो साल के साधारण कारावास एवं $7,60,000$ /- रुपये के अधद्गड एवं अदम अदायगी अर्थदण्ड छ: माह का अतिरिक्त कारावास भुगताने का आदेश दिया गया एवं उसके विरूंद् प्रस्तुत अपील संख्या-66/2018 विद़ान अपीलीय न्यायालग अपर सेशन न्यायाधीश, संख्या-एक, केकड़ी द्वारा निरस्त किये जाने के निर्णय दिनांक 03.09 .2019 के विरुद् प्रस्तुत की गई है।

बहस सुनी गई। निगरानीकार-अभियुक्त के तिद्धान अधिवक्ता ने निवेदन
किया कि वे आलोच्य निर्णय के गुणावगुण पर बहस नहीं करना चाहते हैं और केवल खही सीमित प्रार्थना करते हैं कि विद्वान अपीलीय न्यायालय द्वारा

निगरानीकार-अभियुक्त की अनुपस्थिति में निण्णय पारित किया गया है, अर्थात निगरानीकार-अमियुक्त दारा अपील के समर्थन में अपना पक्ष प्रस्तुत नहीं किया जा सका है, इसलिये उनका निवेदन है कि निगरानीकार-अभियुक्त को विद्धान अपीलीय न्यायालय के समक्ष अपना पक्ष प्रस्तुत करने का अवसर प्रदान करते हुए पुनः सुनवाई़ कर निर्णय पारित करने के निर्देश के साथ प्रकरण अपील न्यायालय को प्रतिप्रेषित किया जाए।

विद्गान अधिवक्ता गैरनिगरानीकार-परिवादी ने इस कम में कोई ऐतराज नहीं किया, बल्कि निगरानीकार-अभियुक्त को अर्वीलय न्याग्यालय के समक्ष अपील में अपना पक्ष रखने हेतु प्रकरण को प्रतिप्रेषित किये जाने में अपनी सहमति प्रदान की है। लेकिन उन्होंने निवेदन किया कि एक निश्चित समयसीमा में प्रकरण को निस्तारित करने के निर्देश दियें जायें।

विचार किया गया। अपीलीय न्यायालय के निर्णय के अवलोकन से प्रकट होता है कि अपीलार्शी (निगरानीकार-अभियुक्त) की अनुपर्थि्थिति में निर्णय पारित किया गया है। निगरानीकार-अभियुक्त विद्यान अपीलीग्र न्यायालय के समक्ष प्रस्तुत अपील में अपना पक्ष रखने के लिये तत्पर है। विद्रान अधिवक्ता परिवादी को इस संबंध में कोर्ईे ऐतराज भी नहीं है। अतः दोनों पक्षों की सहमति को व्यान में रखते हुए न्यायाहित में निगरानीकार्-अभियुक्त को अपना पक्ष रखने का अवसर देते हुए प्रकरण को प्रतिप्रेषित किया जाना उचित है।

परिणामतः मामले के गुणावगुण पर कोई टिप्पणी कियो बिना विद्रान अपीलीय न्यायालय का आलोच्या निर्णय दिनांकित 03.09 .2019 मान्न पुनः सुनवाई किसे जाने के उद्देश्य से अपास्त किया जाता है और दोनों पक्षों को निर्देशित किया जाता है कि वे विद्रान अपीलीय न्यायालय के समक्ष दिनांक 20.07 .2023 को आवश्यक रूप से उपरिशत रहें। दोनों पक्ष प्रकरण में किसी प्रकार के स्थगन की मांग नहीं करेंगे एव अपील में बहस हेतु तैयार रहेंगे। विद़ान अपीलीय न्यायालय उक्त अपील में निगरानीकार-अभियुक्त एवं परिवादी की बहस सुनकार अधिकतम छ: सप्ताह की अवाधि में पुनः विधिसम्मत निर्णय पारित करें।

कार्यालय को निर्देशित किया जाता है कि यदि अधीनस्थ न्यायालय का अभिलेख प्राप्त हो गया हो तो आदेश की प्रति के साथ अविलम्ब अपीलीय न्यायालय को वापस प्रेषित किया जाए।

विद्वान अपीलीय न्यायालय को निर्देशित किया जाता है कि यदि तलबशुदा अभिलेख ड्स न्यायालय को अब तक नहीं भिजवाया गया हो तो अभिलेख दस न्यायालय को भिजवाने की कोर्ड आवश्यकता नहीं है।

तदनुसार यह पुनरीक्षण याच्तिका निस्तारित की जाती है। अन्स्ट लंबित प्रार्थना पत्र, यदि कोर्ई हो, निस्तारित किसे जाते हैं।
