
- Note-**
1. The officers shall dispose off minimum 40% additional work as per circular of standard of work.
 2. The officers who have been appointed as P.O. of outlying Courts in addition to their own duties shall hold Court at the respective places at least for three days in alternative week.
 3. The cases in which accused are in custody or there are directions of higher Court for time bound disposal of case, shall be decided on priority basis.
