2. In case successor takes over charge before issuance of posting order of the Officer concerned, the later shall await his posting order at the same Headquarter.
3. The Officer(s) who have been transferred on request shall not be entitled to claim transfer allowance and joining time.
4. Officer(s) are directed to mention their Unique Identification (UID) Number with their names while sending the report of handing/taking over the charge in accordance with Order No. 4/P.I. Dated 13.03.2023.
