
Order

In pursuance to the recommendation made by Hon'ble Rajasthan High Court, Jodhpur vide their letter No.-Estt.B2(v)/1/WA/2022/810 dated 07-03-2022, the State Government hereby makes the additional appointment of Judicial Officer Ms. Manisha Sharma, Sr.Civil-Judge-Cum-ACJM No-1, Kota as Principal Magistrate of Juvenile Justice Board Kota .

This appointment has been made conferring powers under section 4(2) of the Juvenile Justice (Care and Protection of Children) Act, 2015.

Note-

1. She shall dispose off minimum 40% additional work as per circular of standard of work.
2. The cases in which accused are in custody or there are direction of higher Court for time bound disposal of case shall be decided on priority basis.


