**-:ORDER:-**

In exercise of the powers conferred by Article 233(1) of the Consitution of India read with Rule 43 of the Rajasthan Judicial Service Rules, 2010 the Governor of the State of Rajasthan on the recommendation of the Rajasthan High Court is pleased to appoint the following persons recruited by promotion, Limited Competitive Examination and Direct Recruitment to the Rajasthan Judicial Service in the District Judge Cadre in the pay scale of Rs. 51550-1230-58930-1380-63070 [District Judge (Entry Level)] with such allowances as are admissible as per rules and their pay shall be fixed as per rules. 
