


:: ORDER ::

On recommendation of Hon'ble Rajasthan High Court, Jodhpur Shri Surendra Kumar Jain, District & Sessions Judge, Rajsamand is appointed as Judge, Family Court, Rajsamand in addition to his own duties till further orders, on following conditions.

Note:-


1. **Shri Jain** who has been appointed as P.O. of the Court stationed at the same headquarter in addition to his own duties shall dispose off that much additional work so as to achieve at least 40% of the standard of work for which he is holding additional charge.
2. The cases in which accused are in custody or there are direction of higher Court for time bound disposal of case shall be decided on priority basis.
